# How to Calculate Export Price

**Rationale** : It is observed that exporters having good export product and prepared to offer competitive price either end up in losing export order or are left with loss of profit while quoting price. The reason under both the circumstances is lack of knowledge on pricing methodology for export.

The concept of cost based pricing as applicable in domestic market does not apply in International Market, where prices are fixed by the buyer. Therefore with reference to export always expression **Export Pricing is Used instead of Export Costing.**
